### Section 5 – Important Information for Parents/Guardians

1. This form should be returned to your son/daughter's conductor/music teacher in a timely fashion. **The deadline by which all forms must be received in the NSCF office is 20 January 2012; your conductor/teacher may set an earlier deadline.**
2. The cost to participate in the Children's Chorus of Nova Scotia is \$85/chorister. Payment may be made by cheque or credit card. Details regarding payment are outlined in section 6.
3. Music packets and other information will be forwarded to your son/daughter's music teacher in February 2011. Choristers are expected to practice with the rehearsal CD (provided) and know all notes and rhythms before the regional rehearsal.
4. Regional rehearsals will be held in communities around the province on 3 or 4 March 2011. **Attendance at a regional rehearsal is mandatory, and choristers who are absent may be dismissed from the choir.**
5. The Children's Chorus of Nova Scotia rehearsals will take place in Halifax, 30 March - 1 April 2012. Exact location TBC. A **tentative** schedule is available on the Nova Scotia Choral Federation website at [www.nscf.ns.ca](http://www.nscf.ns.ca).
6. Travel to and accommodations while in Halifax are the responsibility of the chorister's parents/guardians. Billeting options may be available – please inquire with the Nova Scotia Choral Federation office by 20 January 2012 should you like to request a billet while in Halifax. Some meals are provided as outlined on the schedule.
7. The Nova Scotia Choral Federation will provide supervision based on a 1:15 ratio during rehearsals. Once a chorister has been picked up from rehearsal, the ACF shall hold no supervisory responsibility.
8. The Children's Chorus of Nova Scotia concert will take place on the afternoon of Sunday, 1 April 2012. See ticket order form attached.

### Section 6 – Fees and Payment Information

The registration fee for the Children's Chorus of Nova Scotia is \$85, payable at the time of registration. Bursaries are available – application on website. Refunds will not be issued after the registration deadline (20 January 2012). Some meals and snacks are included in the fee (as outlined on the schedule). A high standard of conduct will be expected from Children’s Chorus of Nova Scotia participants at all times. Participants may not leave the grounds of the rehearsal or performance facilities during designated rehearsal and performance times without the express consent of the on-site representative of the NSCF. Any participant who departs the grounds without permission or who behaves in a manner that an NSCF representative or presenter, acting reasonably, considers unacceptable behaviour will be dealt with in a suitable and respectful manner and may be sent home at the participant’s expense with no refund of the registration fee.

NSCF and its representatives will use reasonable efforts to supervise and provide for the well being of participants. However, neither NSCF nor any of its respective directors, executive, employees, staff, instructors, supervisors, clinicians, or technicians shall be liable for any personal injury to a participant or damage to a participant’s property of any nature however caused or arising.

Photographs, recordings, videotapes and the like may be made of participants in the Children’s Chorus of Nova Scotia and may be used in slide shows, videos, brochures, and other materials advertising, promoting, or raising funds for the NSCF. No names will be attached to these photos at any time.
